## **Caste System was Invented by the Greek Colonialists**

In India, before the Greeks (200 CE), there was no archeological evidence of Brahmin, Temples, or Caste System. Idolatry was a Greek invention. Greeks (Europeans) introduced idolatry to India to deliberately and totally destroy the logic-based Hindu civilizations that lived in peace and prosperity for thousands of years. They robbed India blind. An analysis of DNA samples of Indian populations revealed an entirely different story of the ancient Indian history.

People who share the same DNA are called a Haplogroup. The current Indian population consists of the Haplogroups: H, L, J2, O, R2, and R1a. The Haplogroups H, L, J2, O, and R2 were descendants of the F group that left Africa sixty thousand years ago. They were the native Indians, the Hindu. The R1a are the recent European immigrants. They evolved in Europe only six thousand years ago. They moved south from Europe, to the north of Delhi, only four thousand years ago. Hindu lived only to the south of Delhi for sixty thousand years. Hindu were the exact opposite of European cultures. They never had the European concepts of King, War, Weapons, God, or Temple. There was population mobility between the north and south sides of Delhi only after the Greek occupation around 200 CE.

Idolatry was a Greek invention to rob occupied areas. They invested in temples as a business. They promoted local popular heroes to god status to occupy temples. They employed the delusional Persians (R1a1) to invent fictional stories of gods with supernatural powers. They actively promoted the fictional stories as the true history of antiquity. They called the Greek employees engaged in the temple business as Brahmin to offer them a privileged social status for being the Greek stooges.

The real Brahmin who invented the fictional stories of gods and demons with supernatural powers were the R1a1. They were Persians, who lived in exile in Kashmir. They were a cult expelled from Persia. They were on the Greek payroll.

An analysis of DNA samples of the Indian populations revealed that the Caste System had no logical basis. It was pure fiction invented by the Greeks. India Brahmin were recruited from all walks of life to run the temple business. They had nothing to do with the Persians (R1a1) who invented the fictional stories of gods with supernatural powers.

The above table is an analysis of people who claimed to be Brahmin. The Haplogroups C to O and the R2 were the Indians of the African origin. The Haplogroups P to R1a1 were the recent European immigrants. A few Persians (R1a1) followed the Greeks (R1b) to India. They were the Kashmir Brahmin on the Greek payroll.

It is obvious that there is no logical relationship between the people who claimed to be Brahmin and their genetic origin. The native Indians of all Haplogroups claimed to be Brahmin. 

The above table is an analysis of the people of the R2 of African origin. The R2 have dozens of separate castes. The castes do not intermarry or sit at the same table. I belong to the R2 group. I am intimately familiar with the caste categories selected for the study. It is a controlled experiment.

The O and R2 were siblings. The O lived at the Trikuta. The R2 moved to the East Coast. They migrated south starting near the Patna city (Bihar). They traveled along the states Bihar, Odisha (Orissa), Andhra, and Maharashtra. They are found only along this corridor.

Notice that the R1a1 were concentrated only in the Bihar and Odisha States, the area of Greek occupation. They were imported from Kashmir by the Greeks. In India, some of them claimed to be non-Brahmin, to seek employment in the productive sectors. In productive sectors, Brahmin were considered untouchables, for lack of technical skills; they were the unemployable. Naturally, the Greeks exploited the vulnerability with minimum wages. The Greeks invented the rigid Caste System to keep their employees (Brahmin) captive.



The above map shows the ancient migration paths from Africa to India. The F left Africa sixty thousand years ago. They were along the white line before the glaciers started to melt. The rising sea levels swallowed their habitat. They moved to the peninsular India to the south of Delhi. They were the native Indians, the Hindu.
