

## **DNA Distribution in India**

The current version of ancient Indian history was built on a set of false assumptions, by people who lacked scientific skills. It was mostly fiction invented by the Greek colonialists to promote their own agenda. There is ample DNA research to reconstruct the Indian history based on a scientific foundation.

People who share the same DNA are called a Haplogroup. Haplogroups are categorized from A to Z.

An analysis of the DNA samples of the Indian populations revealed that there are only two major Haplogroups in India: (1) Hindu (DNA F), and (2) European immigrants (DNA R1).

Hindu (F) were an advanced logic-based culture who voluntarily left Africa eighty thousand years ago in search of dependable perennial rainwater resources. They made India their home and lived only in the peninsular India, to the south of Delhi.

The land between the rivers Indus and Sutlej was fed by snowmelt water of the Himalayas. It was called Gandhara. It was not rainwater. Hindu lived only along rainwater rivers and lakes. They avoided Gandhara like the plague.

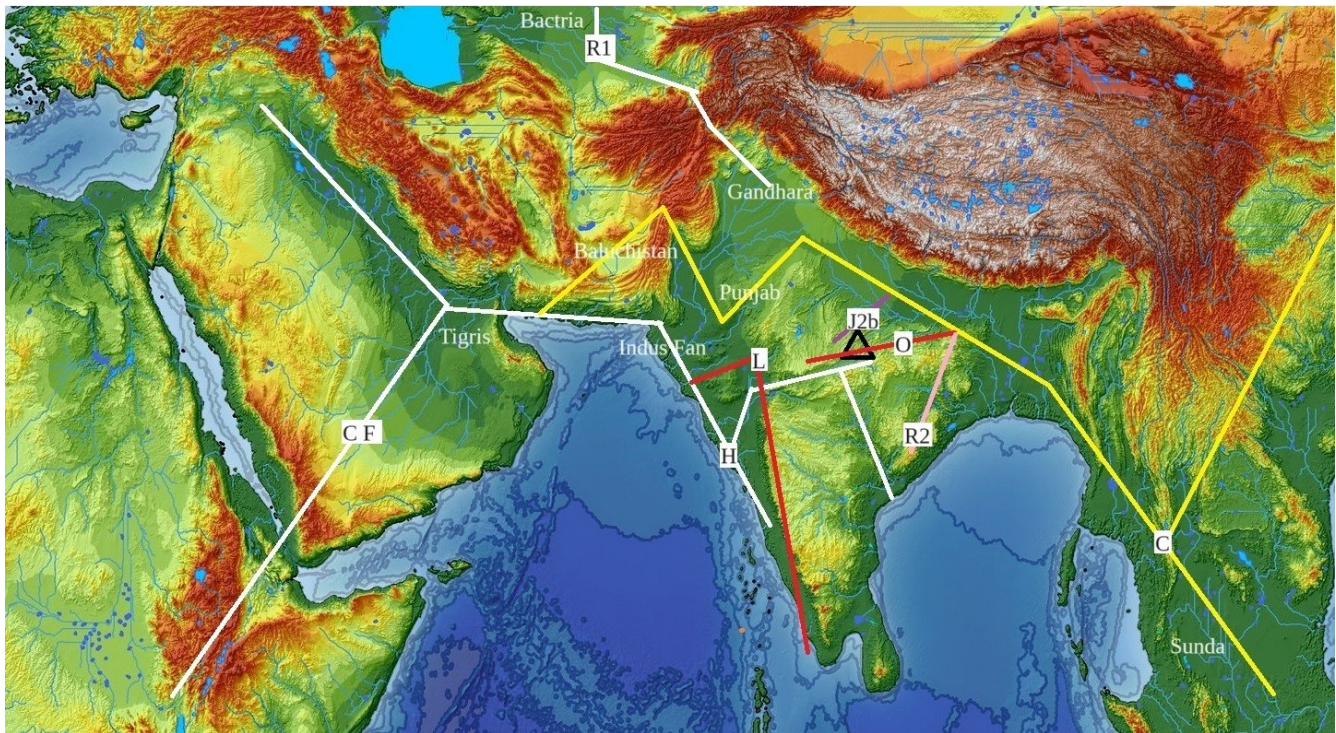
Europe was covered with glaciers until recently. Europe was thawed and was habitable only ten thousand years ago. The primitive European Stone Age culture evolved only ten thousand years ago in the Russian Steppe. The current European cultures evolved only six thousand years ago, from the Stone Age culture. Four thousand years ago, some Europeans moved south and discovered Gandhara. They were the DNA R1. They lived only in Gandhara. Compared to the Steppe, Gandhara was heaven.

The current political boundaries of India include both Gandhara and peninsular India. Peninsular India was the home of Hindu (F) for sixty thousand years. Gandhara was the home of European immigrants (R1) for less than four thousand years.

The F DNA samples are found only in the peninsular India. The R1 DNA samples are found only in Gandhara. The Greek colonialists falsely promoted the immigrants in Gandhara as Hindu. There was population mobility between the two regions only after the Greek occupation.

The F that voluntarily moved out of Africa eighty thousand years ago was subdivided into many groups: H, L, O, R2, and J2b. The population in the peninsular India consists of only these subgroups.

The following map is a computer simulation of the landscape when the F moved out of Africa. At that time, much of the world was covered with glaciers and the seawater was far below the current levels. It shows the density distribution of subgroups of the F, as revealed by the DNA samples of the India populations.



The mountain ridge on the west side of the Red Sea separated Asia from Africa. The F crossed over the ridge to Asia and settled along the Red Sea. At that time, the Red Sea was a natural oasis with inexhaustible supply of rainwater. They moved to the Tigris and Indus Fan. Some people moved north to Baluchistan and discovered a pass in the mountain ridge that led to Punjab the current Thar desert. At that time, it was a fertile valley with perennial rainwater rivers and lakes. The rainwater river Yamuna that originated in Punjab extended all the way up to Sunda on the east side. The yellow line in the above map, along rainwater rivers and lakes, was a major migration path used by C, O, R2, and J2b.

The Mt. Trikuta in the Vindhyas had a giant catch basin with inexhaustible supply of rainwater that fed many rivers from Punjab to Sunda. After the glacial melt and much of the land was submerged, the groups H, R2, O, and J2b sought shelter at the Trikuta.

Before the glacial melt people were only along the yellow line, not the Trikuta.

The L who lived along the current Rann of Kutch, which was a fertile valley at that time, were deprived of the opportunity to reach the Trikuta. They moved south along the coast. The C moved east to reach China.

European cultures (R1) evolved only six thousand years ago, in the Russian Steppe, from the Stone Age culture. They were a distinct category of humans. They migrated south in search of food. Some Europeans reached Gandhara, via Bactria, only four thousand years ago. Europeans evolved in a harsh climate with scarcity of food. They had to compete with animals for food for survival. They acquired the animal survival instincts. They formed into rival packs to rob each other. They were constantly at war. They invented the concepts of King, War, Weapons, God, and Idolatry.

Unlike the logic-based cultures of African origin, the European cultures were ignorance-based. The F and R1 were the exact opposites. The R1 deliberately and totally destroyed the F culture. It was their culture. They vandalized all the logic-based F literature to the ignorance-based R1 literature.

The epic Mahabharata was a fictional story of the warmongering R1 in Gandhara robbing each other. It had nothing to do with Hindu (F) who lived in peace, only in the peninsular India, for sixty thousand years. It was falsely promoted as the history of Hindu. It was the history of Gandhara (R1), not Hindu (F).

All the stories of warmongering gods and demons with supernatural powers were about the R1. It was the European culture, not Hindu culture. Only Europeans had war and god. Hindu (F) never had a war or god in sixty thousand years. They were logic-based peace-loving compassionate people.

All the stories of Brahmin (R1a1) and Kshatriya (R1a) were about the subgroups of R1 who lived in Gandhara. Hindu (F) never had Brahmin or Kshatriya. Hindu were democratic republics with elected administrators called the Rajan. The Rajan were custodians of logic, professors of the Hindu university. Hindu never had the European trademarks of King, War, Weapons, God, or Idolatry.

The stories of Caste System consisting of Kshatriya and Brahmin were Gandhara culture, not Hindu culture. Hindu never had Brahmin, Kshatriya, or Caste System. The R1a1 DNA samples are nonexistent in the peninsular India. The people in the peninsular India who call themselves Brahmin are genetically the F. They were

converted into the fictional Brahmin Caste by the Greeks to serve as their employees in the temple business. They were the Greek stooges.

All the Puranas, Agamas, Vedas, Upanishads, and epics were set in Gandhara landscape, around the Indus. They were the vandalized versions of Hindu logic-based literature, financed by the Greeks, to deliberately and totally destroy the Hindu culture that did not believe in war or god.

The Indus river of snowmelt water avoided by Hindu as the plague was portrayed in the fictional stories as a holy river. It was a vast wasteland before the European immigrants moved in four thousand years ago.

The DNA samples of Indian populations have a fascinating story to tell. One needs an open mind and critical thinking skills to learn the real history of human migrations.
